#### **THE VISION**

Heart disease is second most common and fatal disease after infectious and nutrition related diseases in India. Majority of these heart diseases are treatable and precious lives can be saved. One life saved is one family smiles. As heart diseases are complex matter so also its treatment. This requires support from community, institutions and professionals.

- Heart disease affects all age group, New born to elderly.
- New born suffers from congenital heart disease [holes in heart, blue babies].
- Young & adolescent group suffers from rheumatic heart valvular disease.
- Adults suffer from coronary heart disease [heart attacks].
- Elderly people suffer from hypertension, heart rhythm disorders and also from coronary artery disease.

Heart disease is increasing at a very alarming rate in our country. These cardiac patients require relevant investigation and further medical or surgical treatment. Cardiac rehabilitation and preventive measures are also very important steps in order to control this epidemic of heart disease. Heart surgery has become a rewarding reality, whether it being a heart valve surgery, or coronary bypass surgery or a child with a hole in the heart undergoing surgical closure, all can be successfully treated.

Despite being a successful reality heart surgery is prohibitively expensive costing thousands to lakhs of rupees. Majority of our country's population belong to lower income group. Their income is just sufficient to manage daily expenses, any expenditure on health is simply unaffordable thus bringing misery to family Every needy poor patient suffering from heart disease even if he wants to undergo treatment he / she will have to sell or mortgage property or borrow loan from society to arrange funds as heart disease treatment is expansive.

It is of paramount importance to engage qualified and competent professionals and top quality institutions to provide relief of high standard. In this regard Jain Heart Care Foundation has dedicated itself since 1999.



## WHAT IS THE NEED OF TIME

Heart surgery or any other form of treatment and cardiac rehabilitation must reach every needy patient to avoid tragedies. The provisions provided by government in the field of health care are not sufficient to take care of every increasing population of our country.
